

TOWN OF JEFFERSON
BOARD OF SELECTMEN
February 24, 2014

The regular meeting of the Board of Selectmen for the Town of Jefferson was held at the Selectmen Office Monday February 24, 2014 at 7:00 pm.

PRESENT: Kevin Meehan, Chairman and Tom Brady members comprising a quorum of the Board.

OTHERS PRESENT: Linda Cushman, Assistant to Selectmen, Bruce Hicks; Terri Larcomb Treasurer

Kevin Meehan opened the regular meeting at 7:05 pm. The Board reviewed and approved the bills for payment next week and signed the warrants. The Highway and Transfer Station report was reviewed. Terri Larcomb was in to pick up the signed warrants and sign checks.

Tom Brady made a motion to accept the minutes of the February 10, 2014 Selectmen meeting as presented. Kevin seconded the motion. Motion carries.

A building permit for Diane Allard to construct a house with deck and porch was approved.

The contract with Avery's Sweeper's was signed with a limit of \$1,000, to do the spring sweeping.

Linda was asked to find out if there are any other companies in the area that do street sweeping.

Linda asked if there was any specific information that the Selectmen wanted for presentation at Town Meeting. Tom said that he would like to see information for the bridge articles. Everything else seems to be self-exclamatory. There should be some explanation as to why we are asking to the polling hour change for State elections.

Bruce Hicks wanted to let the Selectmen know what the plans are for the ball field this year. Opening day will be in early May. Bruce said that he would like to have a short parade from the parking lot at Hillside Cemetery to the ball field. There are still a few things that need to be done to complete the field. The monument needs to be set, add flag pole, and equipment for the concession stand. The estimated cost of these items is about \$5000. There is about \$1500 in the Hicks funds and if \$3500 could come from the Athletic Assos. Trust Fund. Bruce said that the only thing that they have not been able to accomplish is to get the playground done. The equipment is expensive and they have not been able to find any grants that would help cover the cost.

Linda informed the Selectmen that she had been communicating with Attorney Cavan Boyles of Littleton. He has a client who owns property in Jefferson. There has been some questions regarding the use of the Jefferson Transfer Station. A copy of the Towns permit was sent to Attorney Boyles showing that Jefferson only except waste that is generated within the Town.

A letter has been sent to Attorney Riff asking what the time frame is for NH DOT doing the driveway

permit for the James Lewis building permit. The driveway permit needs to be approved before the building permit can be approved.

Peter Marchant of KJK Wireless, LLC on behalf of US Cellular has asked if any permits are needed to add antennas for 4G coverage to the US Cellular tower in Jefferson. There will be no change in the tower and no additional work on the ground. The Selectmen said that no additional permitting is needed.

Tom made a motion to adjourn the meeting. Kevin seconded the motion. The motion carries.

Being no further business the meeting adjourned at 8:50 pm.
