BOARD OF SELECTMEN
March 28, 2016

The regular meeting of the Board of Selectmen for the Town of Jefferson was held at the Selectmen Office Monday March 28, 2016 at 6:30 pm

PRESENT: Kevin Meehan, Chair; Tom Brady and Cindy Silver, members comprising a quorum of the Board.

OTHERS PRESENT: Linda Cushman, Assistant to Selectmen; Mark Dubois, Foreman; Josh Smith

Kevin Meehan opened the regular meeting at 6:45 pm after the Safety Meeting. The Board reviewed and approved the bills for payment next week. The Highway and Transfer Station report was reviewed. The warrants were signed. Terri Larcomb was in to pickup signed warrants and sign checks.

Tom Brady made a motion to accept the minutes of the March 21, 2016 Selectmen Meeting as written. Cindy Silver seconded the motion. Motion carries.

Mark Dubois reported that he has completed the maintenance on the grader. He says that the grader may need 4 new tires. He believes the radials would be the better purchase. The tires that are on it were purchased in 2010 and for the use have not lasted that long. The radials would be about \$1500 each.

Josh Smith of the local cystic fibrosis organization to discuss the use of the Couture Ball Field. They would like to continue to use the field for their annual softball tournament. This will be the 10th year that they have held a softball tournament to raise funds for cystic fibrosis. They raise three to four thousand dollars during the weekend. They will provide an insurance certificate along with copies of the waivers each player signs. Mr. Smith said that they make sure that the field is left as good as they found it. The tournament will be held May 28 and 29. The tournament has teams from all over the State participating. It was mentioned that the field needs new bases. Mr. Smith said that he should be able to get some slightly used bases from Colonel Town. Cindy said that she is the Athletic Association president and asked him to contact Bruce Hicks regarding the bases.

Tom made a motion to accept the re-appointments of Jeffrey Young, Gordon Rebello and Michael Meehan to the Planning Board as recommended. Cindy seconded the motion, motion carries.

Kevin reported that Donna Laurent of the Planning Board was willing to be the representative for the NCC Transportation Advisory Commission. Tom made a motion to appoint Donna Laurent to the NCC TAC. Cindy seconded the motion, motion carries.

Current Use applications for Clayton and Diana Lizak and Michael and Susan Figg was approved and signed.

Tom made a motion to adjourn the meeting. Cindy seconded the motion, motion carries.
