

TOWN OF JEFFERSON
BOARD OF SELECTMEN
May 16, 2016

The regular meeting of the Board of Selectmen for the Town of Jefferson was held at the Selectmen Office Monday May 16, 2016 at 6:30 pm

PRESENT: Kevin Meehan, Chair; Tom Brady and Cindy Silver, members comprising a quorum of the Board.

OTHERS PRESENT: Linda Cushman, Assistant to Selectmen; Mark Dubois, Highway Foreman;

Kevin Meehan opened the regular meeting at 6:40 pm. The Board reviewed and approved the bills for payment next week. The Highway and Transfer Station report was reviewed. The warrants were signed. Terri Larcomb was in to pickup signed warrants and sign checks.

Tom Brady made a motion to accept the minutes of the May 9, 2016 Selectmen Meeting as presented. Cindy Silver seconded the motion. Motion carries.

Mark Dubois said that he is having an issue getting a sweeper. Seems that everyone is booked. Two companies will be here next week to see if they can do the sweeping and give a quote.

Grading on the Ingerson Road is finished, and they are working on Sunset Paradise. On Sunset there needs to be more ditching done. Mark figures that it would take about a week to do.

Mark asked if the Board had made a decision on the material to use on the Ingerson Road. They said that they hadn't looked at the options and will do so. Mark was asked if he preferred the ledge pak or the gravel. He said the ledge pak was good, however it was hard to grade. The best would be to mix the two materials.

The annual review of the Hazard Mitigation Plan was completed. This Plan will need to be updated in 2017 to comply with regulations. Jefferson is on the 2016 grant list for this project. The Emergency Operation Plan was also reviewed.

New Hampshire Interlocal Trust has determined that Jefferson is due a share of FY15 contributions in the amount of \$434.91. This amount can be credited to FY 17 premiums or refunded in total. The Board elected to take the credit in check form for the 2017 year.

Cindy reported that the Athletic Assoc. will not have any extra funds to cover any of the anticipated maintenance of the Hicks ball field. The Association pays for the umpires and other supplies for the teams.

Linda Cushman reported that she did not have to report for jury duty this week. The next time may be June 7th.

A building permit for James Quirk was reviewed and approved. Mr. Quirk will build a shed on property on Chambers Road.

Pistol permits were signed for Ron Costa, Richard Dean, Scott Kayel and Heather Bushey.

The next meeting will be held Monday May 23, 2016 6:30 pm.

Tom made a motion to adjourn the meeting. Cindy seconded the motion, motion carries.

Being no further business the meeting adjourned at 7:15 pm.
