

TOWN OF JEFFERSON
BOARD OF SELECTMEN
September 28, 2015

The regular meeting of the Board of Selectmen for the Town of Jefferson was held at the Selectmen Office Monday September 28, 2015 at 6:30 pm.

PRESENT: Norman Brown, Chairman; and Kevin Meehan , members comprising a quorum of the Board.

OTHERS PRESENT: Linda Cushman, Assistant to Selectmen; Mark Dubois, Highway Foreman; Jimmey Howland Transfer Station Attendant; Chris Milligan, Fire Chief

Norman Brown opened the regular meeting at 6:37 pm. The Board reviewed and approved the bills for payment next week. The Highway and Transfer Station report was reviewed. The warrants were signed. Terri Larcomb was in to pickup signed warrants and sign checks.

Kevin Meehan made a motion to accept the minutes of the September 21, 2015 Selectmen Meeting. Norman seconded the motion, the motion carries.

Mark Dubois reported that they are getting ready for paving on the Ingerson Road hill. The ditches have been cleaned. Norman asked if the entrance of the cemetery needed any work before being paved. No, it looks in good shape. There are a couple more trees that need to be cut and should finish that this week. Got Walker Road ditched and graded. There is some clean up on Enman Drive that needs to be finished on the south side.

The winter sand is slow now because it took to long to get the salt delivery, we are on the end of the delivery list.

Kevin asked if when they are at the Transfer Station if something could be done to the road. On the lower side it is rough.

Norman asked if the vehicles were ready for winter. Mark said that the only thing that should be done is to purchase 2 retreads for the International. The retreads work as well as anything. The cost is about \$170 each.

It is planned to work on the Hazen Road next week. The brush will be cut back, the ditches look all right for now.

Clayton Christie has informed the Board that the Beattie is finishing up the work he is currently doing and should get started on the bridge mid week. P & R construction will be working with Beattie. When the old bridge is taken out there is a place to store it at the garage.

Mark was asked to be thinking about any projects that will need to be funded for 2016 budget. Mark said that most everything has been completed. The wiring at the garage is finished. The water heater hasn't been installed yet. The chimney will get done this fall.

A proposal from Kevin Conway of \$500 was received for the property that borders his on the Bailey Road. Kevin Meehan made a motion to accept the proposal of \$500 from Kevin Conway for Lot 30 a 1-acre lot. Norman seconded the motion, motion carries.

Linda was instructed to prepare the deed for the property and notify Mr. Conway.

The quarterly safety meeting was held from 7:00 to 7:30 pm.

There was some discussion regarding the paving in the village area, especially the catch basins. When Route 2 was paved the catch basins were not raised, some are now very deep which leads to concerns of safety. A letter will be written to the District 1 office asking that these catch basins be inspected.

The next meeting will be October 5, 2015, at 6:30 pm.

Kevin made a motion to adjourn the meeting. Norman seconded the motion. The motion carries.

Being no further business the meeting adjourned at 7:55 pm.
