

TOWN OF JEFFERSON
BOARD OF SELECTMEN
October 5, 2015

The regular meeting of the Board of Selectmen for the Town of Jefferson was held at the Selectmen Office Monday October 5, 2015 at 6:30 pm.

PRESENT: Norman Brown, Chairman; Kevin Meehan and Tom Brady, members comprising a quorum of the Board.

OTHERS PRESENT: Linda Cushman, Assistant to Selectmen;

Norman Brown opened the regular meeting at 6:30 pm. The Board reviewed and approved the bills for payment next week. The Highway and Transfer Station report was reviewed. The warrants were signed. Terri Larcomb was in to pickup signed warrants and sign checks.

Kevin Meehan made a motion to accept the minutes of the September 28, 2015 Selectmen Meeting. Norman seconded the motion, the motion carries.

Linda Cushman reported that they will be bring in equipment this week and start working on the bridge. Linda said that she asked Clayton Christie to have signs posted at the end of the road on both ends letting people know the bridge is closed.

NH Interlocal Trust our health insurance carrier has presented the rate for renewal at 6.4% being a \$50.28 monthly increase per employee, a \$1206.72 yearly increase

Tom Brady made a motion to accept the quote for health insurance from NHIT plan HMO 15 500 (MD13960) in the amount of \$835.89 per single plan. Kevin seconded the motion, motion carries.

In beginning the budget process for 2016 the Selectmen reviewed the current budget and discussed if there were any projects that would need to be addressed in the 2016 year. Norman states that at this time the Town buildings are in good shape. He would like to see what work is left at the cemeteries.

Josie Cote made an offer to purchase lot 19A map 14 for personal use in the amount of \$2000. Ms. Cote is the owner of the lot directly in front of this lot. Kevin made a motion to accept the offer of \$2000 for lot 19A map 14. Tom seconded the motion, motion carries.

It was mentioned that Mark Dubois should check the shoulder on the west side of the Ingerson Road from the cemetery to Route 2.

The Selectmen said that if someone wants something from the scrap metal pile that they should let the Attendant know and the Attendant will have it set aside. The item will only be kept for a reasonable amount of time then it will be put into the container for recycling.

Superintendent Anastasia and James Brady, School Board member will be in October 19, 2015 at 6:30 to discuss the Superintendents plans for the future.

The next meeting will be October 19, 2015, at 6:30 pm.

Kevin made a motion to adjourn the meeting. Norman seconded the motion. The motion carries.

Being no further business the meeting adjourned at 7:55 pm.
